

Guidelines for filling the Anti Ragging form

- In pursuance to the Judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009, in exercise of the powers conferred by clause (g) of sub-section (1) of section 26 of the University Grants Commission Act, 1956, the UGC notified "Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009". The Regulations are available on the UGC website <http://www.ugc.gov.in> & www.antiragging.in
- DHE/University/UGC/AICTE has issued advisory to take adequate steps to prevent ragging in accordance with these Regulations.
- In this regard, you are also requested to fill online compliance on [antiragging.in](http://www.antiragging.in) website.
 - **STEP 1** : Visit www.antiragging.in
 - **STEP 2** : Click on '**Undertaking**' → '**Register**'
 - **STEP 3** : Choose the Educational Institution Type as '**College**'
 - **STEP 4** : Fill your **Personal details and Parent / Guardian Details.**
 - **STEP 5** : Under College and Course Details, select state as **Haryana** and College name as **<Your College Name>**.
 - **STEP 6** : Type in the below details as given:
 1. College Principal Name as **<Principal Name>**
 2. College Phone Number (+91) - **<Mobile No.>**
 3. Select the mandatory details of the Course viz.
 - Details of the course (UG/PG/Diploma)
 - Name of the Course in which student admitted
 - Current year of study
 - Nearest Police station to your College
 - **STEP 7** : Check all boxes under UGC Regulations.
 - **STEP 8** : Fill in the Confidential Survey.
 - **STEP 9** : Recheck the form and confirm that all the details are correct.
 - **STEP 10**: Click Submit Form.
 - **STEP 11**: On successful submission, you will receive Reference ID. Note down this Reference ID.
 - **STEP 12** : Click on '**Undertaking**' → '**Download**'.
 - **Step 13**: Enter Reference ID, Email and Mobile No and click on submit button.
 - **STEP 14**: Student Antiragging Affidavit and Parent/Guardian Undertaking will be downloaded.
 - **STEP 15**: Open Admission Portal i.e. <https://admissions.highereduhry.ac.in>
 - **Step 16**: Login with your username and password.
 - **Step 17**: Enter the Reference ID and other details on admission portal under the TAB → "Antiragging Affidavit" and submit the same.

Note:- Following Details will be required on www.antiragging.in Portal while filling up the form:-

- *Name of College*
- *Name of Principal/Director*
- *Contact No. of Principal/Director*

Mandatory Completion of Anti-Ragging Affidavit Steps 15, 16 & 17 **on Admission Portal**

This is to inform all students that as per UGC Guidelines and College directions, every student must complete the Anti-Ragging Undertaking process. It has been observed that many students are completing steps till Step 14 only and NOT completing Step 15, 16 and 17 on the admission portal. All students are hereby advised and directed to complete the following steps immediately :

Steps to be Completed Compulsorily:

STEP 15: Open Admission Portal i.e. <https://admissions.highereduhry.ac.in>

STEP 16: Login with your username and password

STEP 17: Enter the Reference ID received from <http://www.antiragging.in> and other required details under the TAB → “Antiragging Affidavit” and submit the same

Without uploading/submitting the Antiragging Affidavit on the admission portal, your admission will be considered incomplete.

एडमिशन पोर्टल पर एंटी-रैगिंग एफिडेविट स्टेप्स 15, 16 और 17 को पूरा करना जरूरी है

सभी स्टूडेंट्स को यह बताना है कि UGC गाइडलाइंस और कॉलेज के निर्देशों के अनुसार, हर स्टूडेंट को एंटी-रैगिंग अंडरटेकिंग प्रोसेस पूरा करना होगा। यह देखा गया है कि कई स्टूडेंट्स एडमिशन पोर्टल पर सिर्फ स्टेप 14 तक ही स्टेप्स पूरे कर रहे हैं और स्टेप 15, 16 और 17 पूरे नहीं कर रहे हैं। सभी स्टूडेंट्स को सलाह और निर्देश दिया जाता है कि वे नीचे दिए गए स्टेप्स तुरंत पूरे करें :

स्टेप्स जो ज़रूरी हैं :

स्टेप 15: एडमिशन पोर्टल यानी <https://admissions.highereduhry.ac.in> खोलें

स्टेप 16: अपने यूजरनेम और पासवर्ड से लॉगिन करें

स्टेप 17: <http://www.antiragging.in> से मिली रेफरेंस ID और दूसरी ज़रूरी डिटेल्स TAB → “एंटीरैगिंग एफिडेविट” में डालें और सबमिट करें

एंटीरैगिंग एफिडेविट को एडमिशन पोर्टल पर अपलोड/सबमिट किए बिना, आपका एडमिशन अधूरा माना जाएगा।
